CHS GUIDELINES

CHS DATES:June 30- August 29

The week of August 25 we will be offering a part time schedule for CHS approved campers only.

PENDING CHS APPROVAL:

If you are applying for CHS coverage, but have not yet been accepted onto the program, you are required to apply to camp as private campers and include all private camper payments with your application. If you get accepted onto CHS before or in middle of the summer, you will be refunded for the dates covered by CHS.

IMPORTANT GENERAL NOTE:

When you enroll your child/ren in Camp Azamrah or Elite Teen Camp, you are responsible for the full day camp balance and must readily take responsibilityin case of any missing CHS payments. Iffor any reason all or part of the CHS payment does not come through you will be billed privately at the CHS rate for the missing sum, even if you fulfilled all your CHS requirements and are entitled to the funding. Any sum that is not received by Camp Azamrah! by October 1, 2025, will be billed privately to the parents. Upon receiving the payment from CHS, Camp Azamrah! will refund you.

SECURITY DEPOSIT:

In case of outstanding CHS payments, all CHS approved applicants are required to provide a form of payment that will be charged for the missing sum. We will first contact you to notify you of the missing sum and that we will be using your security deposit.

At the checkout screen of this application, you will be given the option to leave either credit card info or ACH info for a security deposit.

CHS REGISTRATION FEES:

In the table beloware the non-refundable registration fees due with your application.

The **early bird special** of **\$25 off per camper per half** will be applied to these registration fees if you apply by the following deadlines:

Returning Azamrah Campers- By January 12 at 1:30 pm (before the reunion)

Returning campers currently in grades 5-6- By January 19

New Azamrah & Elite Campers- By January 29

PAYMENT BY ENROLLMENT OR ATTENDANCE:

CHS is currently paying by enrollment, which means that swiping in and out is not necessary and all absence days are covered. If they will change this policy to paying by attendance for summer 2025, parents will be required to swipe daily, or back swipe once in every 14 calendar days, and covered absence days will be limited. It will be the responsibility of the parents to ensureaccurate swiping.

SUMMER AGREEMENTS:

Case workers usually start issuing summer agreements in March. We will iyH send out reminder calls and texts at that time. Agreements must be requested at least ten days before the start of care.

Camp Azamrah! and Camp Elite are both recognized by CHS as Camp Azamrah. The dates to be submitted for CHS summer agreements are **June 30- August 29**. The last regular day of camp is August 22, but we will iyH be offering a part time program the following week, details to follow.

Please email your agreement to **campazamrah@gmail.com** to be signed. Once you receive your completed agreement back from our office, **please be sure to send it to your caseworker**.

All agreements must be emailed into CHS, as opposed to being mailed or faxed, so that there is record of submission. We've had incidents of campers not being covered due to CHS saying that they did not receive their agreement. When the agreement was submitted via mail or fax, campers were often denied funding, and parents were billed privately. However, when agreements were emailed in and there was proof of submission, CHS provided funding. Therefore, we are requiring that all agreements be emailed into CHS as opposed to being mailed or faxed.

POLICY FOR CHS APPLICANTS WITH A PARENT IN GRADUATE SCHOOL:

I understand that with this registration I am hiring Camp Azamrah and obligating myself to ensure that they receive full tuition forthis entire term, even if my child does not attend the camp, unless an unforeseen and unfortunate circumstance makes it unfeasible for my child to attend the camp. This obligation applies even if my child cancels before the start of the summer.

I am agreeing to the following 3 policies:

- 1. If I will be terminated from CHS before the summer, or I will not be able to procure summer agreements for my children due to my status, I will be billed at the camp'sprivate camper rate (posted on campazamrah.com), and mysecurity deposit (info above) will be billed for the private feeduring the month of June (I will be notified in advance iyH).
- 2. Once I reserve a slot for the upcoming summer, I will be unable to back out due to losing my CHS coverage.
- 3. If I will beterminated from CHS any time between registering my children in camp and the start of the summer, or if I will be unable to procure summer agreements for my children due to my status, I shall notify the Camp immediately.

I have executed a valid kinyansuder in a Bais Din Chasuv, and accept any halachic opinion, even a minority opinion, that supports the validity and enforceability of this Agreement and its implied intent. The undersigned parties agree, to submit to binding arbitration, all claims associated with the abovementioned child's participation in the above-mentioned program, including those against the childcare providers and/or the owner of the premises, to be heard and determined by Rabbi Shmuel Honigwachs, in accordance with their standard arbitration practices. Their decision shall be considered final and

enforceable in court. By sending this document for the parent's signature, the Camp is deemed to have signed and accepted the terms, and the agreement does not have to be countersigned by the Camp.
